### 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media** Water spray, fog, CO<sub>2</sub>, dry chemical, or alcohol resistant foam.

### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions, protective equipment and emergency procedures** Keep unnecessary personnel away. Avoid contact with skin or inhalation of spillage, dust or vapor.
