#### 5. FIRE-FIGHTING MEASURES

**Suitable extinguishing media** Water spray, fog, CO<sub>2</sub>, dry chemical, or alcohol resistant foam.

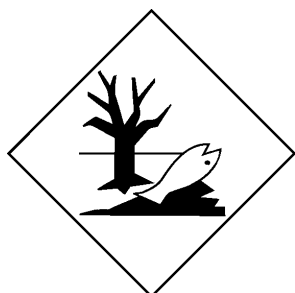
